For appointment by initial recruitment	=	30 marks

In case of appointment by initial recruitment as well as appointment by promotion in BPS 1 to 16, the academic marks for the prescribed (eligibility) qualification shall be taken into account and calculated as follows:

a. for appointment by initial recruitment:

b. for appointment by promotion:
